Annual Village Election Notice.

The Citizens of the Village of Nevis in the County of Hubbard and State of Minnesota, who are qualified to vote at general elections, are hereby notified, that the Annual Election of said village will be held at the Roberts Building in said Village on Tuesday, the 8th day of March A. D. 1921, between the hours of Nine o'clock in the forenoon and Five o'clock in the afternoon of the same day, for the following purposes, viz;

To elect one President for the term of one year; one Trustee for the term of three years; one Treasurer and one clerk each for the term of one year; and one Assessor for the term of two years; one justice of the peace and one constable each for the term of two years.

Also, To vote on the question whether such Village of Nevis will continue to exist under the special act of the legislature and amendments thereto, incorporating the same, or will become re-incorporated under the Revised Laws, 1905 Section 699 and amendments thereto; and to do any other business proper to be done at said Election when convened.

MINUTES OF THE PROCEEDINGS OF VILLAGE COUNCIL.

Village of Nevis, Minnesota, February 15th, 1921.

The village council of the Village of Nevis met at the office of the Village Clerk in said Village of Nevis on the 15th day of February, 1921, at eight o'clock P. M.

Members present: The president and trustees, Edward Erickson, Ole Engstad, S. M. Potter; no absentees. The minutes of the regular meeting held on the 7th day of February, 1921, were read and on motion of trustee Edward Erickson approved as read. The matter of the re-incorporation of the Village of Nevis organized under Chapter 145, Minnesota Laws 1885, was brought up for discussion. Trustee Ole Engstad offered the following resolution:

Resolved, to submit at the next annual election the question whether such Village of Nevis will continue to exist under the special act of the legislature or under Chapter 145, Minnesota Laws 1885, and amendments thereto, incorporating same or will become re-incorporated under revised laws of 1905, Section 699 and amendments thereto. Such election to be held on the 8th day of March, 1921, from 9 o'clock A.M. until 5 o'clock P.M. of said day at the Roberts building in said village of Nevis, to be voted by ballot and the ballot to read "For re-incorporation - Yes - No." , with a square after each of the last two words in one of which the voter may insert a cross to express his choice, and the election conducted and result canvassed as provided for in the annual village election. If the majority vote for re-incorporation, the council will certify and file the result thereof with the county auditor and another with the secretary of state, and thereupon the original incorporation of said village of Nevis shall be deemed surrendered and the said village of Nevis shall become incorporated under the revised laws of 1905 and acts amendatory thereto.

Said resolution was duly adopted by unanimous vote, upon roll call, trustees Edward Erickson, Ole Engstad, S. M. Potter, President O. H. Gregerson and the clerk voting in favor thereof, there being no dissenting votes.
