To the Honorable Board of County Commissioners of Carlton County, Minnesota,
Sirs:

The undersigned, all residents and legal voters of the territory hereinafter described, being desirous of having said territory incorporated as a Village, and separated from Town of Silver for all purposes as provided by Chapter Nine, General Statutes of Minnesota, 1913, and acts amendatory thereof and supplementary thereto, respectfully show and petition your Honorable body as follow:

That a census was duly taken of all of the resident population in said territory hereinafter described, so proposed to be incorporated into a Village, between the 20th. day of February, and the 24th. day of February, 1921, and that the actual resident population of said territory as shown by said census was One Hundred Eighty (180) residents.

That the name of such proposed Village shall be "Kettle River".

That the area and boundaries of said proposed Village shall be as follows:

The Northwest quarter of the southeast quarter ($NW\frac{1}{4}$ of $SE\frac{1}{4}$) and the West Half of the Northeast quarter ($W\frac{1}{2}$ of $NE\frac{1}{4}$) and the East Half of the Northwest quarter ($E\frac{1}{2}$ of $NW\frac{1}{4}$) and the Northeast quarter of the southwest quarter ($NE\frac{1}{4}$ of $SW\frac{1}{4}$) section Nine (9), Township Forty-six (46), Range Twenty (20), which said premises are bounded as follows: Commencing at the center of the Southeast quarter of said section Nine (9), thence running due North following the East one-sixteenth line of said Section to the Northeast corner of the Northwest quarter of the Northeast ($NW\frac{1}{4}$ of the $NE\frac{1}{4}$) thence due West following the North Section Line of said section to the Northwest Corner of the Northeast quarter of Northwest Quarter ($NE\frac{1}{4}$ of $NW\frac{1}{4}$) of said section (9); thence due South to the Southwest Corner of the Northeast quarter of the Southwest Quarter ($NE\frac{1}{4}$ of $SW\frac{1}{4}$) of said section Nine (9); thence due East following the South one-sixteenth Line of said section (9) to the place of beginning, All in section Nine (9), Township Forty-six (46), Range Twenty (20), Carlton County, Minnesota, containing Two Hundred Forty (240) Acres.

That a portion of the above described premises has already been duly platted into lots and blocks under the names of "Odberg's Plat of the Townsite of Kettle River," and "Addition A to Odberg's Plat

of the Townsite of Kettle River, "Townsite of Finland," and that all of said Plats have been duly recorded in the Office of the Register of Deeds in and for said County of Carlton, State of Minnesota; that the remainder of the above described territory lies adjacent to the above described platted portion thereof.

WHEREFORE, Your petitioners respectfully petition your Honorable Body to call an election for the determination of such proposed incorporation.

A verified petition purporting to be signed by at least twentyfive voters of the territory composed of the Northwest quarter of the Southeast quarter, (NW¹/₄ of SE¹/₄) and the West half of the Northeast quarter (W¹/₂ of NE¹/₄) and the East half of the Northwest quarter (E¹/₂ of NW¹/₄) and the Northeast quarter of the Southwest quarter, (NE¹/₄ of SW¹/₄), all in Section Nine (9), Township Fortysix (46), Range Twenty (20), asking that said territory be incorporated into a village to be known as Village of Little River, was presented to the Board for their action thereon. WHEREAS, a census in due form has been filed with the Board of County Commissioners of Carlton County, Minnesota, showing that certain territory, in a certain petition described, has a population of 180; and
