ORDINANCE NO. 244

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM TO INCLUDE APPROXIMATELY 19 ACRES OF UNPLATTED LAND ABUTTING UPON THE CITY LIMITS

WHEREAS: a certain petition dated Mar. 3, 1971 requesting annexation of the territory hereinafter described was duly presented to the council on the 6th day of April 1971, and

WHEREAS: the quantity of land embraced within the area described in the petition and bounded as described is approximately 19 acres of unplatted land, no part of which is included within or abuts the limits of any other incorporated city, village or borough, and

WHEREAS: the petition was signed by all of the owners of the described property; and

WHEREAS: copies of the said petition were duly filed with the Town Board of Great Bend Township and County Board of Cottonwood County, being the Town and County in which all of the land proposed to be annexed is located, on Mar. 3, 1971 and

WHEREAS: under date of April 1, 1971 the Town Board of Great Bend Township approved of said petition and elected not to exercise its right to enter objections to said annexation and

WHEREAS: the land described in the petition abuts upon the city limits at a North boundary thereof;

BE IT ORDAINED BY THE CITY OF WINDOM, MINN. AS FOLLOWS:

SECTION 1: The City Council hereby determines (1) that the annexation will be to the best interest of the City and to the territory affected; (2) that none of the territory is now included within the limits of any other city, village or borough

SECTION 2: The corporate limits of the city are hereby extended to include the unplatted land hereinafter described and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof.

SECTION 3: The description of the land located in the Township of Great Bend and Cottonwood County, Minn. which is hereby annexed as follows to wit:

The N. E. $\frac{1}{4}$ of the S. E. $\frac{1}{4}$ of Section 36, Township 105 North, Range 36 West of the 5th Principal Meridian, Cottonwood County, excepting the following described tracts:

Beginning at a point 1449.65 feet East and 2499.22 feet South of the Southwest corner of Block 2 of Reddings First Addition to the City of Windom, said point being 70.00 feet South of the North line of the S. E. $\frac{1}{4}$ of said Section 36; thence South 15°-52' East a distance of 192.83 feet; thence South 50°-20' East a distance of 250.00 feet; thence South 21°-50' East a distance of 235 feet, more or less, to a point 580.00 feet West of the East line of said Section 36 and 670.80 feet North of the South line of the N. E. $\frac{1}{4}$ of the S. E. $\frac{1}{4}$ of said Section 36; thence Easterly, along a line parallel with and 670.80 North of the South line of the South line of the N. E. $\frac{1}{4}$ of the S. E. $\frac{1}{4}$ of said Section 36, to the centerline of Cottonwood County Road No. 43; thence Northerly and Westerly, along said centerline, to a point 70.00 feet South of the North line of the S. E. $\frac{1}{4}$ of said Section 36; thence South 89°-57' West, along a line parallel with and 70.00 feet South of the North line of the S. E. $\frac{1}{4}$ of said Section 36, a distance of 781.72 feet, more or less, to the point of beginning. Said tract containing 8.84 acres, more or less.

Also that part of the North Half of the Southeast Quarter (N $\frac{1}{2}$ SE $\frac{1}{4}$) described as follows: Beginning at the one-eighth stake on the Township line East of the Southeast Quarter marked by a gas pipe in Section 36; thence North 8 $\frac{1}{4}$ degrees West 580.8 feet along the Township line; thence South 81 degrees West 750 feet to a point 17 feet East of the river bank; thence South 8 $\frac{1}{2}$ degrees East 580.8 feet to a point in the Des Moines Riverbed; thence North 81 degrees East 750 feet to the point of beginning; Said tract containing 10 acres, more or less.

Also that part of the North Half of the Southeast Quarter (N $\frac{1}{2}$ SE $\frac{1}{4}$) described as follows: Beginning at the one-eighth stake on the Township line East of the Southeast Quarter (SE $\frac{1}{4}$) marked by gas pipe in Section 36, Township 105 North, Range 36 West; thence North 8 $\frac{1}{4}$ degrees West 580.8 feet on Township line to the point of beginning; thence South 81 degrees West 750 feet; thence North 90 feet; thence in an Easterly direction to a point 90 feet North of the point of beginning; thence South 90 feet to the point of beginning. Said tract containing 1.5 acres, more or less.
