



To whom it may concern:

The St. Paul City Railway Company, a corporation organized and existing under the laws of the State of Minnesota, now owning and operating the street railway property within the City of St. Paul, State of Minnesota, hereby declares that it desires that each of the grants contained in the following, to-wit:

Chapter 113, Special Laws of Minnesota for 1873, entitled:

"An Act to Revive, Continue and Amend an Act Entitled "An Act to Revive and Continue an Act and the Corporation Created by Said Act, Entitled "An Act to Incorporate the St. Paul and St. Anthony Railroad Company," approved March Second, One Thousand Eight Hundred and Fifty-Three, and to Amend the said Act," approved March 4, 1860."

as the same has since been amended and now exists, which said grant is now owned by The St. Paul City Railway Company;

Ordinance No. 57 of the City of St. Paul, entitled:

"An ordinance to authorize the construction and operation of horse railways in certain streets of St. Paul,"

approved January 8, 1873, as the same has since been amended and now exists, which said grant is now owned by The St. Paul City Railway Company;

Ordinance No. 1857 of the City of St. Paul, entitled:

"An ordinance authorizing The St. Paul City Railway Company to construct, equip, maintain and operate street railway lines in the City of St. Paul,"

approved September 20, 1889, as the same has since been amended and now exists, which said grant is now owned by The St. Paul City Railway Company;

and any other grant or grants from the State of Minnesota or the City of St. Paul or any municipality under which said The St. Paul City Railway Company now operates any street railway line or street railway property within said City of St. Paul, shall become an interminate permit under the provisions of Chapter 378, Laws of Minnesota for 1881, (Senate File No. 687), and concreto that the terms of said Chapter 378 shall apply to and govern the ownership, control, management, maintenance and operation of the street railway property of said The St. Paul City Railway Company.
