**ORDINANCE NO. 84.**

**An Ordinance Relating to the Sub-  
jection of the City of Faribault to  
the Statute Granting Additional  
Powers to Cities and Empower-  
ing them to Issue their Bonds for  
Certain Purposes.**

**THE COMMON COUNCIL OF THE  
City of Faribault do Ordain:**

**SECTION 1.** The City of Faribault is  
subject to the provisions of a certain  
act of the Legislature of the State of  
Minnesota, approved April 12th, A. D.  
1893, entitled "An Act to grant Addi-  
tional Powers to the Cities of the State  
of Minnesota and to empower such cit-  
ies to issue their bonds for certain pur-  
poses therein mentioned."

**SECTION 2.** This ordinance shall take  
effect and be in force from and after its  
publication.
