

A meeting of the Chief Executives of communities in Anoka and Washington Counties was held to elect a Chairman to meet with the County Commissioners from said counties to elect a nominee to be representative on the Metropolitan Transit Commissions

The meeting was called to order at 8:20 P.M., Wednesday, February 10, 1971 by the Anoka County Auditor, Charles R. Lefebrre in the County Commissioners Room at the Anoka County Court House.

Those present from Anoka (ounty included the following: Robert C. Haywood-Blaine, Ernest Koehler-Burns, Marcel Hivard-Centerville, Lende O. Anderson-Circle Pines, Bruce Nawrocki-Columbia Heights, Conrad Carlson-Columbus Township, Bob Voss-Coon Rapids, Jack O. Kirkham-Fridley, Louis Appleby-Grow Township, Ralph L'Allier-Lino Lakes, Frank Gabrick-Linwood Township, Ernest W. Knutson-Oak Grove Township, Dave Ballstadt-Spring Lake Park, and Ray Jones-St. Francis.

Those present from Washington County included the following: Robert L. Walcotz-Cottage Grove, Robert E. Rife-Forest Lake Township, J. J. Gessell-Forest Lake, J. P. Perzishilli-Hugo, James Hab-Landfall, M. W. Axebod-St. Paul Park, and Bill Powell-Stillwater.

Also present were Robert W. Johnson, Canoka County Attorney; Charles R. Lefebvre, Anoka County Auditor, and Delonis Heintz, Recording Secretary.

Robert W. Johnson reported on the law as it now reads in regard to this meeting. A quorum of Chief Executives was not reached. Robert Johnson explained the alternatives for this situation and the Chief Executives choose to continue with the meeting being that they represented a majority of votes in both counties, 154 votes present from the maximum of 191.

Charles Lefebvre names Robert Haywood Temporary Chairman of this meeting.

Nominations were called for the Chairman for the Joint Meeting of the County Commissioners from Anoka and Washington Counties. Robert Voss nominated, Ralph L'Allien seconded the nomination of Bruce Nawrocki.

Bill Powell moved to close nominations, Robert Walcotz seconded, motion carried.

Bill Powell moved to cast a white ballot in favor of Bruce Nawrocki, Dave Ballstadt seconded, motion carried.

Resolution: That we natify this meeting and this nomination because, we present represent a majority of vote on population, 154, and a majority of population, 137,587.

Bruce Nawrocki asked for a discussion of the peoples feelings in regard to Metropolitan Transit planning. Most Mayor's reported on the feelings of their particular community.

Meeting was adjourned at 9:20 P.M.



JOINT MEETING OF WASHINGTON COUNTY AND ANOKA COUNTY COMMISSIONERS

Washington County Office Building Stillwater, Minnesota

March 15, 1971

A joint meeting of the Washington and Anoka County Commissioners was called to order at 8:00 o'clock P. M. by Bruce Nawrocki, Mayor of Columbia Heights, pursuant to his previous election by the Chief Executives of the municipalities in the two counties, pursuant to M.S. 473A.04, Subd. 5, to serve as joint meeting chairman. Said meeting was called pursuant to notice given under said statute for the purpose of electing a Transit Commissioner to represent Washington and Anoka Counties for the remainder of the term which expires July 1, 1972.

On motion by Roy Johnson, Anoka County Commissioner, seconded by Robert Wright, Washington County Commissioner, and carried, T. R. Greeder was elected to serve as Recording Clerk for the meeting.

A thorough discussion was held concerning the purposes and goals of the Metropolitan Transit Commission, methods of financing, and possible service to the two counties. Chairman Nawrocki called for nominations for the office of Transit Commissioner. Anoka County Commissioner Kordiak nominated

Bruce Nawrocki, nomination was seconded by Anoka County Commissioner O'Bannon. Washington County Commissioner Pederson nominated Stanley J. Olander of the Village of Woodbury, nomination was seconded by Washington County Commissioner Tibbetts. Chairman Nawrocki called three times for additional nominations, and thereafter on motion by Anoka County Commissioner Johnson, seconded by Washington County Commissioner Wright, and carried, nominations were closed.

After discussion of the procedure to be followed, a secret ballot was held, and Anoka County Attorney Johnson and Washington County Attorney Jansen were appointed to act as tellers. The ballot was held, and the tellers reported the following results:

Nawrocki -- 5 votes Olander -- 5 votes

A further discussion was then held as to procedure and the two County Attorneys advised that pursuant to statute, Chairman Nawrocki was entitled to break the tie, but that additional ballots could be held if the Commissioners so desired. At the request of Washington County Commissioner Pederson, the Chairman called a recess at 9:05 P. M. for the purpose of a caucus by the Washington County Commissioners.

At 9:15 P.M., Chairman Nawrocki reconvened the meeting. Washington County Commissioner Pederson commented on the need for close communication between the Transit Commissioner and the County Commissioners of the two counties. Similar comments were made by several other Commissioners including Anoka County Commissioners O'Bannon and Kordiak and Washington County Commissioner Cafferty. Chairman Nawrocki indicated that if he were elected, it was his intention to maintain a close liaison with the two Boards.

Washington County Commissioner Pederson moved that the nomination of Mr. Olander be withdrawn and that a unanimous ballot be cast for Bruce Nawrocki. The motion was seconded by Washington County Commissioner Tibbetts and carried unanimously.

On motion by Anoka County Commissioner O'Bannon, seconded by Washington County Commissioner Pederson and carried, the meeting was adjourned at 9:40 P.M.
