ORDINANCE NO. 1291

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES ABUTTING THE CITY LIMITS.

WHEREAS, a Petition was filed requesting the annexation of the territory hereinafter described, which Petition was duly presented to the Common Council on the 2nd day of November, 1970, and

WHEREAS, the quantity of lands embraced within the area described in the Petition and bounded as described is 48.4 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the Petition was signed by all the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City of Austin at the North boundary thereof;

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1) The City Council hereby determines, 1) that the annexation will be to the best interests of the City and of the territory affected, 2) that the territory described herein abuts the city limits, and is about to become urban or suburban in character, and 3) that none of said territory is now included within the limits of any city, village or borough.

SECTION 2) The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City of Austin as effectually as if it had originally been a part thereof:

The following portions of Section 33, Township 135 North, Range 13 West, Mower County, Minnesota, to-wit: (a) That part of the Northeast Quarter of the Southwest Quarter of said Section 33 lying Southeasterly of the Southeasterly boundary of Interstate Highway No. 90; (b) That part of the West half of the southeast Quarter of the South west Quarter of said Section 33 lying Southeasterly of the Southeasterly line of Interstate Highway No. 90 and Northerly of the center line of Freeborn Road as said road is shown on the plat of Norman Park Second Addition recorded in Book 7 of Plats, page 32, except the parts thereof lying within the platted lots of said Norman Park Second Addition and except the parts thereof conveyed by Johnson to Combs by the two deeds recorded in Book 234 of Deeds, page 516 and Book 274 of Deeds, page 373, respectively; (c) That part of the Southwest Quarter of the Southwest Quarter of Section 33, lying East of the part conveyed to Morgan by deed recorded in Book 267 of Deeds, page 243 and North of Outlot 24 in said Norman Park Second Addition; (d) The North 48 rods of the East half of the Southeast Quarter of said Section 33; also beginning on the South line of said North 48 rod tract at a point 5 rods East of the Southwest corner thereof, thence South 15 rods on a line parallel with the West line of said section, thence East 20 rods on a line parallel with the South line of said section, thence North 16 rods on a line parallel with the West line of

said section, to the South line of said North 48 rod tract, thence West 20 rods on the South Line of said 48 rod tract to the point of beginning; - Said tracts A, B and C containing 29.4 acres more or less, and said Tract D containing 14 acres more or less.

SECTION 3) The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Township Clerk of Lansing Township.

SECTION 4) The Ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
