ORDINANCE No. 158

AN ORDINANCE ANNEXING LAND TO THE CITY OF GLENWOOD
THE CITY OF GLENWOOD DOES ORDAIN:

Section 1. City of Glenwood does annex and make a part of the City of Glenwood, the following described property which adjoins the City of Glenwood and which said property is wholly owned by the City of Glenwood:

The West ten acres (W10) of the Northeast Quarter of the Northeast Quarter (NE1/4 NE 1/4), Section One (1), Range One hundred twenty-five (125), Township Thirty-eight (38), County of Pope, State of Minnesota.

Section 2. This annexation is made under the provision of Sub-division Two, Section 414.033 Minnesota Statutes.
