AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WABASSO TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJUTING ON THE VILLAGE LIMITS

WHEREAS, a certain petition dated April 13, 1971, requesting annexation of the territory hereinafter described was duly presented to the Council on the 3rd day of May, 1971; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 2/3 of an acre of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the owners, and

WHEREAS, no objections to the annexation have been received from the town board, the county, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits on the east boundary thereof;

The Council of the Village of Wabasso, Minnesota ordains:

Section 1. The village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.


Section 2. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof: Commencing at a point Five Hundred Forty-seven (547) feet North of the Southwest Corner of Section Twenty-four

(24), Township One Hundred Eleven (111), Range Thirty-seven (37), running thence East One Hundred Seventy-eight (178) feet, thence at right angles North One Hundred Seventy-one and five-tenths (171.5) feet, thence at right angles West One Hundred Seventy-eight (178) feet, thence at right angles South One Hundred Seventy-one and five-tenths (171.5) feet to the place of beginning containing approximately 0.7 of an acre.


Section 3. Filing. The Village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.


