

ORDER

The Minnesota Municipal Commission received a petition for the detachment of land from the City of Sauk Centre, Minnesota, on the 10th day of August, 1971, by the landowners. A resolution for the detachment of the same land was filed by the City of Sauk Centre on June 11, 1971, and an amendment thereto on August 10, 1971.

The territory involved consists of the following:

Lot 4 south of road adjoining Lot 3 and between said Lot 3 and Mill Pond, Section 4, Township 126, Range 34, County of Stearns, State of Minnesota.

The property is adjacent to the City of Sauk Centre and said lands are unplatteed and used primarily for agricultural purposes. The petition is in proper legal form and sets forth the information required in Minnesota Statutes 414.06 and upon the files and records, the Minnesota Municipal Commission being fully advised in the premises,

IT IS ORDERED: That the foregoing described real property be, and the same hereby is, detached from the City of Sauk Centre, and made a part of the Township of Sauk Centre, Stearns County, the same as if it had originally been made a part thereof.
