ORDINANCE NO. 114.

An ordinance approving of and accepting chapter two hundred and four of the general laws of Minnesota, passed and approved during the 28th session of the legislature, commencing January 3d, 1893.

The city council of the city of Red Wing do ordain:

SECTION 1. That chapter two hundred and four (204), of the General laws of Minnesota passed and approved during the twenty-eighth (28th) session of the legislature, commencing January third (3d), one thousand eight hundred and ninety-three (1893), and known as house file number forty-eight (48), entitled "An act to grant additional powers to cities of the state of Minnesota and to empower such cities to issue their bonds for certain purposes therein mentioned," be and hereby is approved and accepted as to each and every section thereof according to the provisions of section five (5) in said chapter two hundred and four (204).

SECTION 2. This ordinance shall take effect and be in force from and after its publication. Passed January 10th, 1894.

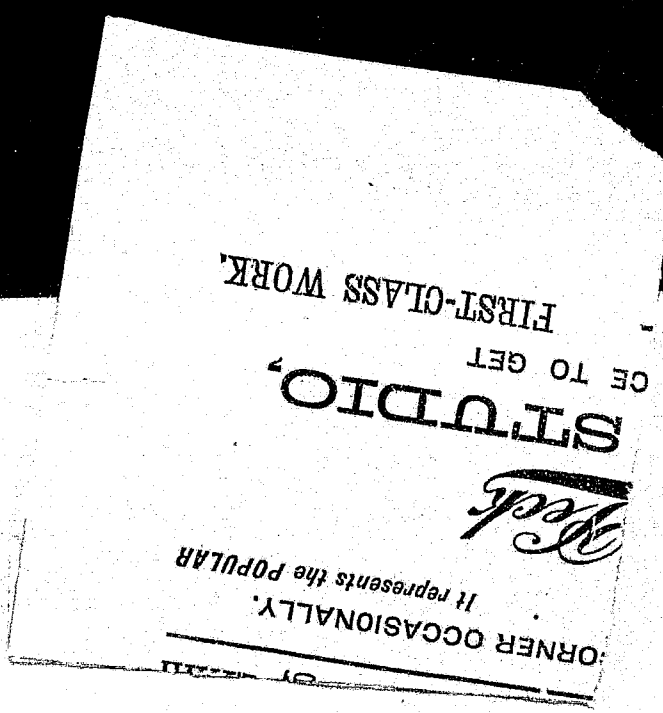
