ORDINANCE NO. 1971-C

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ST. JOSEPH TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LANDS NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain Petition dated May 7, 1971 requesting annexation of the territory hereinafter described was duly presented to the Council on the 7th day of May, 1971; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 16 acres of unplatted land, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the Petition was signed by all of the owners of said tract; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of that land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the Village limits at its southeasterly boundary;

THE COUNCIL OF THE VILLAGE OF ST. JOSEPH, MINNESOTA, ORDAINS:

Section 1. The Council hereby determine

(a) That the annexation will be to the best interest of the Village and the territory affected;

(b) That the territory described herein abuts upon the Village limits and is about to become urban or sub-urban in character;

(c) That none of said territory is now included within the limits of any city, village or borough.

Section 2. The corporate limits of the Village are hereby extended to include the unplatted land described as follow and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof;

That part of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Ten (10), Township One Hundred Twenty Four (124) North of Range Twenty Nine (29) East, Stearns County, Minnesota described as follows. Beginning at a point on the West line of said Northwest Quarter of the Southeast Quarter which point is Two Hundred Eight and Sixty Six Hundredths (208.66) feet due South of the point of intersection of the West line of said tract and the Southerly right-of-way line of old Trunk Highway Number 52; thence North 85 $^{\circ}$ 41' East Two Hundred Eight and Seven tenths (208.7) feet; thence due North Sixty Six Hundredths of a foot (0.66) thence due East eighty (80) feet; thence due North Two Hundred Fourteen and Four Hundredths (214.04) feet; thence North 8 $^{\circ}$ 41' East Sixty and Seventeen Hundredths (60.17) feet; thence due South Two Hundred Eight (208) feet; thence due East Six (6) feet; thence due North Forty Five Hundredths (0.45) feet; thence due East Two Hundred Eight (208) feet; thence due North Twenty Seven and Seven tenths

(27.7) feet; thence due East One Hundred Forty Two (142) feet; thence due South Sixty (60) feet; thence due East One Hundred Fifty Two and Fifteen Hundredths (152.15) feet; thence South 89°31' West Six Hundred Sixty Three and Twenty Seven Hundredths (663.27) feet to a point on the South line of said NW $\frac{1}{4}$ SE $\frac{1}{4}$; thence, along said South line, South 89°42' West Eight Hundred Fifty and Twenty Eight Hundredths (850.28) feet to the Southwest corner of said NW $\frac{1}{4}$ SE $\frac{1}{4}$; thence along the West line of said NW $\frac{1}{4}$ SE $\frac{1}{4}$, North Six Hundred Seventy Two and Six tenths (672.6) to the point of beginning. Also that part of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of said Section Ten (10), Township One Hundred Twenty Four (124) North of Range Twenty Nine (29) West, Stearns County, Minnesota, described as follows: Commencing at an iron monument at the Southeast corner of said NW $\frac{1}{4}$ SE $\frac{1}{4}$; thence along the South line of said NW $\frac{1}{4}$ SE $\frac{1}{4}$, South 89°42' West One Hundred Seventy One and Six tenths (171.6) feet to the point of beginning of the tract herein described; thence North 00°31' East Three Hundred Thirty Two and Four Hundredths (332.04) feet; thence South 90°00' West Two Hundred Eighty Three and Two Tenths (283.2) feet; thence South 00°31' West Three Hundred Thirty Three and Twenty Eight Hundredths (333.28) feet; thence North 89°42' East Two Hundred Eighty Three and Two Tenths (283.2) feet to the point of beginning.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor, and the Register of Deeds.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
