ORDINANCE NO. 176

ORDINANCE ANNEXING ADJOINING LANDS

The City Council of the City of Madison do ordain:

Section 1: That the following described land adjoining the limits of the City of Madison, located in the County of Lac qui Parle, State of Minnesota, is hereby added to, taken into and made a part of the City of Madison, to-wit:

All of Lot 12, the East one-half of Lot 13, the North 20 feet of Lot 14, together with the street dedicated as Park Avenue and the township road right-of-way located between said North 20 feet of Lot 14 and the corporate limits of the City of Madison; the East 300 feet of Lot 15 and the North 20 feet of Lot 15 except said East 300 feet thereof; the East 300 feet of Lot 16, all in Evergreen Addition to Madison, according to the plat thereof on file and of record in the office of the Register of Deeds of said county, said land being situated in the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$ ) of Section 21, Township 118 North, of Range 44 West, excepting from said Lot 16 a tract described by metes and bounds as follows: Commencing at the Southeast corner of said Lot 16, this point also being the South Quarter Corner of said Section 21, running thence north on and along the easterly boundary line of said Lot 16 a distance of 381 feet, thence westerly on a line parallel with the north boundary line of said Lot 16 a distance of 300 feet, thence southerly on a line parallel with the easterly boundary line of said Lot 16 to the point of intersection with the south line of said Lot 16, this line being the same line as the south line of said Section 21, thence easterly along said south line of said Lot 16 to the point of beginning, subject to right-of-way of State of Minnesota Trunk Highway 40, as now laid out and established.

Section 2: That on the taking effect of this ordinance the corporate limits and boundary lines of the City of Madison shall be and are hereby extended to include the easterly, southerly and northerly boundaries of the above described tract of land.

Section 3: This ordinance shall be in full force thirty days from and after its passage.
