

AN ORDINANCE

To accept and become subject to the provisions of an act passed by the Legislature of the State of Minnesota, entitled "An act to grant additional powers to the cities of the State of Minnesota, and to empower such cities to issue their bonds for certain purposes therein mentioned," approved April 12, 1893.

The Common Council of the City of Waseca do ordain:

Section 1. That the city of Waseca does hereby accept and become subject to an act and all the provisions of an act passed by the Legislature of the State of Minnesota at its session in 1893, entitled "An act to grant additional powers to the cities of the State of Minnesota, and to empower such cities to issue their bonds for certain purposes therein mentioned," approved April 12, 1893; and that the City of Waseca shall hereafter be subject to the provisions of said act, and shall be governed, controlled and regulated by and under the provisions of said act.

Section 2. That upon the passage of this ordinance by a three-fourths vote of all the members of the Common Council of said City and the approval and publication thereof as provided by the charter of the City of Waseca the City recorder shall forward to and file in the office of the Secretary of State a certified copy of this ordinance so approved and duly certified, accompanied by a statement of the vote of the Common Council thereon with the names of the members voting for and against this ordinance.

Section 3. This ordinance shall take effect and be in force from and after its publication.
