ORDINANCE NO. 1588
AN ORDINANCE Annexing to The City of Rochester Minnesota, Certain Platted Land in Auditor's Plat "D" and Certain Unplatted Land, All Being in The North Half, Section 34, Township 107 North, Range 14 West, Olmsted County, Minnesota; and Establishing The Zoning Therefor.

THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:
Section 1. The Common Council of the City of Rochester by resolution adopted on February 1, 1971, declared its intent to annex the following described land in Cascade Township, Olmsted County, Minnesota, which is 60 per cent or more bordered by the City of Rochester:

PARCEL A
Lots 2, 3, 4, and 5 as platted in Auditor's Plat "D" and all of the abutting right-of-way of 7th Street N.W.

PARCEL B
All that part of the right-of-way of T.H. No. 52 in the Northeast Quarter, Section 34, Township 107 North, Range 14 West, lying north of the Chicago Northwestern Railroad right-of-way.

PARCEL C
Commencing at Northeast corner of Northwest Quarter of Section 34, Township 107 North, Range 14 West, for a place of beginning; thence south 33 feet; thence west 237.85 feet; thence south, along the east line of lot 1 & 2 Hall's 1st Add., a distance of 350 feet to the Southeast corner of said lot 2; thence west along the south line of said lot 2, a distance of 262.50 feet to the east right-of-way line of Valleyhigh Drive N.W.; thence south along said east right-of-way line to a point 110 feet north of the intersection of the north line of 7th St. N.W. & east line of Valleyhigh Drive N.W.; thence east perpendicular to the east line of Valleyhigh Drive N.W., a distance of 110 feet, thence south parallel with the east line of Valleyhigh Drive N.W., to the center line of 7th Street N.W., thence southerly along said centerline a distance of 69.34 feet. Thence southerly at right angles to said center line, a distance of 130.60 feet to the north right-of-way line of Chicago Northwestern Railroad; thence southerly along said R.R. Right-of-way line, a distance of 392.70 feet, to the east line of the Northwest Quarter, Section 34, Township 107 North, Range 14 West; thence northerly along said east line, a distance of 1311.48 feet, more or less, to the point of beginning.

The said resolution was thereafter duly served upon the Town Board of Cascade Township, and after said service, sixty days has elapsed without objection being filed by the Town of Cascade with the Minnesota Municipal Commission.

Section 2. The land described in Section 1 above comprising of approximately 26.0 acres is hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if it had been originally a part thereof.

Section 3. Present and future owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the Common Council to assess against benefited property all or a portion of the cost of any storm sewer, water tower and trunk line sanitary construction heretofore or hereafter, undertaken to serve the area annexed.

Section 4. Pursuant to Section 14.06 of Ordinance No. 1296, as amended, known as the Zoning Ordinance of the City of Rochester, Minnesota, the lands herein annexed to the City of Rochester shall be designated on the Zoning Map of said Ordinance No. 1296 in the districts indicated as follows:

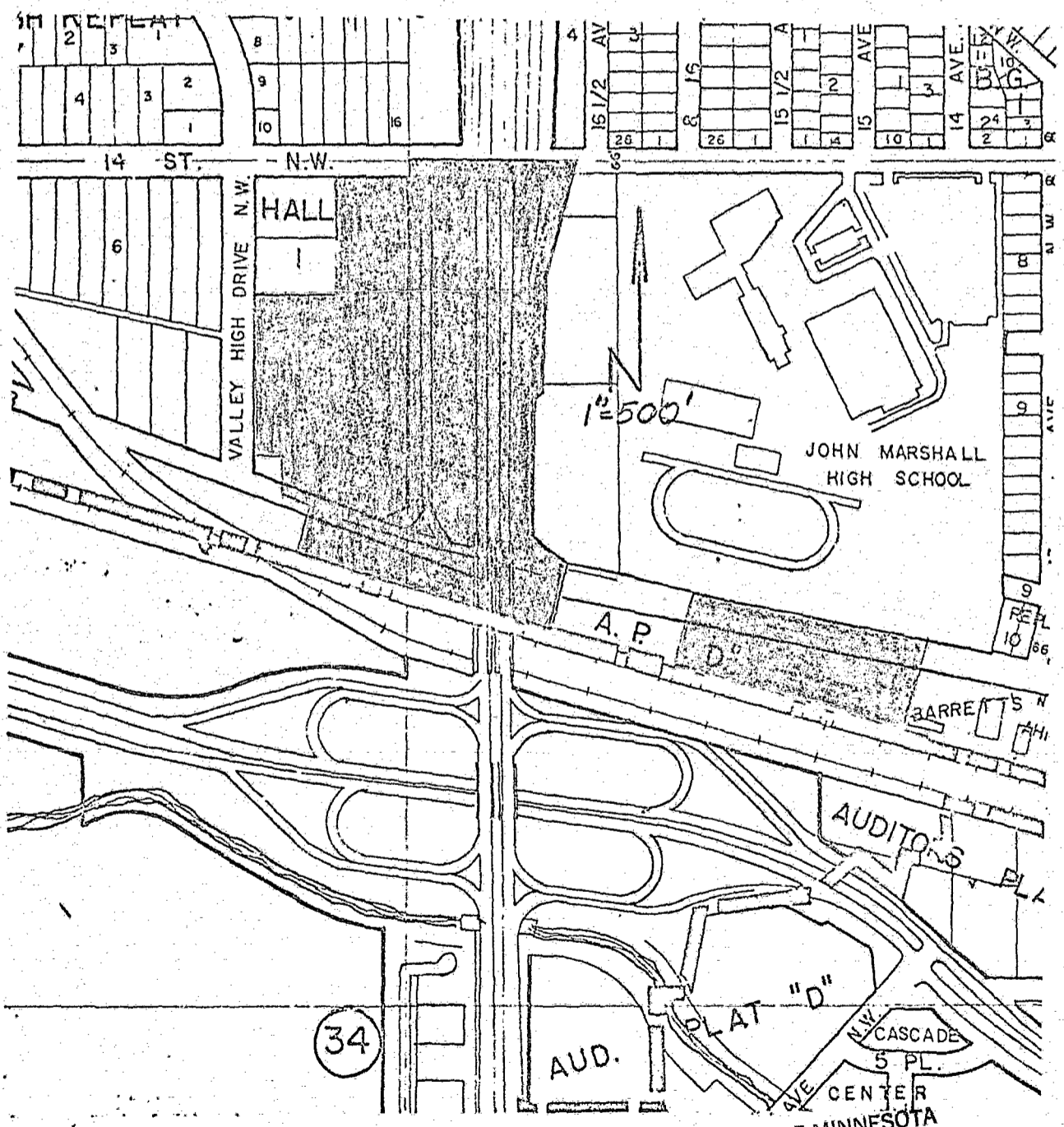

R-3 Multi-Family Residence District
All that part of the right-of-way of T.H. No. 52 in the Northeast Quarter, Section 34, Township 107 North, Range 14 West, lying north of the Chicago Northwestern Railroad right-of-way and east of the centerline of said T.H. NO. 52.
M-1 Light Manufacturing District
Lots 2, 3, 4, and 5 as platted in Auditor's Plat "D" and all the abutting right-of-way to the center line of 7th Street N.W.
M-1 Light Manufacturing District
All that part of the right-of-way of T.H. No. 52 in the Northeast Quarter, Section 34, Township 107 North, Range 14 West, lying north of the Northwestern Railroad right-of-way and south of the center line of 7th Street N.W.
M-2 General Manufacturing District
Commencing at Northeast corner of Northwest Quarter of Section 34, Township 107 North, Range 14 West, for a place of beginning; thence south 33 feet; thence west 237.85 feet; thence south, along the east line of lots 1 & 2 Hall's 1st Add., a distance of 350 feet to the Southeast corner of said lot 2; thence west along the south line of said lot 2, a distance of 262.50 feet to the east right-of-way line of Valleyhigh Drive N.W.; thence south along said east right-of-way line to a point 110 feet north of the intersection of the north line of 7th St. N.W. & east line of Valleyhigh Drive N.W.; thence east perpendicular to the east line of Valleyhigh Drive N.W., a distance of 110 feet, thence south parallel with the east line of Valleyhigh Drive N.W., to the center line of 7th Street N.W., thence southerly along said centerline a distance of 69.34 feet. Thence southerly at right angles to said center line, a distance of 130.60 feet to the north right-of-way line of Chicago Northwestern Railroad; thence southerly along said R.R. right-of-way line, a distance of 392.70 feet, to the east line of the Northwest Quarter, Section 34, Township 107 North, Range 14 West; thence northerly along said east line, a distance of 1311.48 feet, more or less, to the point of beginning; and including all that part of the abutting right-of-way of T.H. No. 52 in the Northeast Quarter, Section 34, Township 107 North, Range 14 West, lying North of the Chicago Northwestern Railroad right-of-way and west of the center line of T.H. No. 52.
Section 5. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the Cascade Town clerk, the County Auditor and the Secretary of State.
