ORDINANCE No. 87

ANDS

AN ORDINANCE ANNEXING CERTAIN LANDS
TO THE VILLAGE OF STEWARTVILLE

UNERRAS, a petition for annexation of lands herinafter described, duly signed by all of the owners of the land proposed for annexation has been filed with the Village of Stewartville,

AND IMPEREAS, copies of said petition have been filed with the Minnesota Municipal Commission, the High Forest Town Board and the Olmsted County Board,

AND UMEREAS, the objection filed by the High Forest Township has been withdrawn in a letter from their attorney dated July 26, 1971,

AND WHEREAS, no Public Hearing is required because the Village has been authorized to proceed with annexation in a letter from the Minnesota Municipal Commission dated August 2, 1971,

AND WHEREAS, the Village Council has determined that the annexation is in the best interest of the Village of Stewartville and the territory affected,

THE VILLAGE COUNCIL OF STEWARTVILLE DOES ORDAIN:

1. The following described lands are hereto annexed and made a part of the Village of Stewartville; Lands situated in the County of Olmsted, State of Minnesota, to-wit:

The West Half of the Northwest Quarter of Section Thirtyfive in Township One Hundred Five, North of Range Fourteen West,

The West Half of the Southeast Quarter of the Northwest Quarter of Section Thirtyfive, Township One Hundred Five North, Range Fourteen West.

2. The Village Clerk shall file a certified copy of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.
