AN ORDINANCE ANNEXING CERTAIN LANDS
TO THE VILLAGE OF STEWARTVILLE

WHEREAS, a petition for annexation of lands hereinafter described, duly signed by all of the owners of the land proposed for annexation has been filed with the Village Council of the Village of Stewartville:

AND WHEREAS, copies of said petition have been filed with the Minnesota Commission, the High Forest Town Board, and the Olmsted County Board:
