An ordinance passed to entitle the City of Mankato to the benefits of the provisions of Chapter 204 of the General Laws of the State of Minnesota for the year 1893, "entitled an act to grant additional powers to the cities of the State of Minnesota to empower such cities to issue their bonds for certain purposes therein mentioned."

Be it ordained by the Common Council of the City of Mankato.

Sec. 1. That the said City of Mankato hereby elects to become subject to the provisions of Chapter 204 of the General Laws of the State of Minnesota for the year 1893, the same being an act to grant additional powers to the cities of the said State of Minnesota, and to empower such cities to use their bonds for certain purposes in said act mentioned, and the said City of Mankato hereby adopts the provisions of said act as a part of the Charter thereof to enable it to enjoy and receive the provisions thereby granted.

Sec. 11. This act to take effect and be in force from and after its passage, and after a duly certified copy thereof is filed in the office of the Secretary of State, as is provided by Section five of Chapter 204 of the laws of 1893,
