## ORDINANCE NO. 40.

An Ordinance adopting and accepting an act to grant additional powers to cities of the State of Minnesota and to empower such cities to issue their bonds for certain purposes therein mentioned.

The City Council of The City of New Prague do Ordain:

Section 1. That Chapter Two bundred and four (204) of the General laws of Minnesota for the year Eighteen hundred and ninety-three (1898) being an act to grant addi-florial powers to cities of the State of Milmosota and to empower such cities to issue their bonds for certain pumposes therein mentioned, including water and light bonds therein mentioned, be and the same is hereby accepted and adopted by the City of New Prague.

Section 2. This Ordinance shall take effect and be in force from and after its puclication.
