Allen J. Selsell Secretary of State AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND OR UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory abuts upon the corporate limits of the City at the south boundary thereof, and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the City;

THE CITY COUNCIL DOES ORDAIN:

Section I. Territory Annexed. The corporate limits of the City of Mankato are hereby extended to include the platted property described as follows, now owned by the City:

Beginning at the Northeast corner of the Southwest quarter of the Northeast quarter of Section 24, Township 108 North, Range 27 West; thence South, along the East line of the Southwest quarter of the Northeast quarter, and the East line of the North half of the Northwest quarter of the Southeast quarter of said Section 24, 1993.95 feet to the Southeast corner of the North half of the Northwest quarter of the Southeast quarter of said Section 24; thence West, along the South line of the North half of the Northwest quarter of the Southeast quarter of said Section 24, 1321.75 feet to the Southwest corner of the North half of the Northwest quarter of the Southeast quarter of said Section 24; thence North, along the West line of the North half of the Northwest quarter of the Southeast quarter, and the West line of the Southwest quarter of the Northeast quarter of said Section 24, 1764.14 feet to a point on the West line of said Southwest quarter of the Northeast quarter, 224.40 feet South of the Northwest corner of the Southwest quarter of the Northeast quarter of said Section 24; thence North 89 degrees 25 minutes East, parallel to the North line of the Southwest quarter of the Northeast quarter of said Section 24, 606.80 feet; thence North 03 degrees 14 minutes West, 75.30 feet; thence North 03 degrees 48 minutes West, 25.00 feet; thence North 00 degrees 28 minutes West, 25.00 feet; thence North 02 degrees 45 minutes East, 25.00 feet; thence North 06 degrees 12 minutes East, 25.00 feet; thence North 10 degrees 16 minutes East, 25.00 feet; thence North 13 degrees 19 minutes East, 25.00 feet to the North line of the Southwest quarter of the Northeast quarter of said Section 24; thence North 89 degrees 25 minutes East,

along said North line, 722.60 feet to the Northeast corner of the Southwest quarter of the Northeast quarter of said Section 24, said point being the point of beginning. Said above described tract containing 51.893 acres, more or less, all in Blue Earth County, Minnesota.

Section II. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section III. Effective Date Of Annexation. This ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies as herein described.
