

ORDINANCE NO. 248

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM,
MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY
LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, Certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the City of Windom and is deemed to be urban in character; and

WHEREAS, said territory is approximately fifteen acres in area; and

WHEREAS, on May 25, 1971 the City caused notice of intent to annex said territory to be duly served upon the Town Board of Great Bend Township; and


WHEREAS, no objections to said annexation have been filed with the Minnesota Municipal Commission.


BE IT ORDAINED, BY THE CITY OF WINDOM, MINNESOTA AS FOLLOWS:

1. The City Council hereby determines that the annexation will be to the best interest of the City and to the territory affected and that none of the territory is now included within the corporate limits of any other city, village or borough.
2. The corporate limits of the City of Windom, Minnesota are hereby extended to include the platted and unplatted territory in Great Bend Township, Cottonwood County, Minnesota as follows; 60% or more of the perimeter of which territory is bordered by territory already included within the city limits:

All that part of the Southwest Quarter of the Southwest Quarter of Section 24, Township 105, Range 36 lying Southwesterly of the Northeasterly right-of-way line of Trunk Highway No. 71, which is not presently within the city limits of the City of Windom.

WHEREAS, certain territory described below is not presently
included within the corporate limits of any incorporated city,
village or borough; and

WHEREAS, 60% or more of the perimeter of this territory
is bordered by lands already included within the corporate limits
of the City of Windom and is deemed to be urban in character; and

WHEREAS, said territory is approximately fifteen acres in
area; and

WHEREAS, on May 25, 1971 the City caused notice of intent
to annex said territory to be duly served upon the Town Board of
Great Bend Township; and

WHEREAS, no objections to said annexation have been filed
with the Minnesota Municipal Commission.

BE IT ORDAINED, By the City of Windom, Minnesota as
