TO WHOM IT MAY COME: I, the undersigned, Clerk of the City of Worthington, Minnesota, do hereby certify that the following is a true and correct copy of the original as the same appears in the records of the City of Worthington, Minnesota.

The City Council of the City of Worthington, do hereby:

Section 1. Petitions are here filed with the City Council of the City of Worthington, Minnesota, signed by one of the owners in favor of the following land within the City of Worthington, Minnesota:

Part of the Northeast Quarter of Section 36, Township 1 N., Range 1 W., Nelson County, Minnesota, described as follows: Beginning at a point located by the intersection of the center line of said road projected easterly to the south line of said tract and the westerly line of said tract; thence easterly on the westerly line of said tract and the easterly line of said tract a distance of 115 feet; thence at right angles westerly and on a line parallel to the easterly line of said tract, to a point opposite the point of beginning; thence at right angles northerly to the point of beginning, describing a tract 115 feet by 115 feet.

Section 2. The quantity of land entered within the foregoing description, and bounded and described is .65 acres.

Section 3. Notice was duly given the Board of Commissioners for Nelson County and the Board of Commissioners for Worthington Township on June 2, 1971, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein does come upon the City and is so conditioned as property to be subjected to city government.

Section 5. The corporate limits of the City are hereby extended to include the property described in Section 1, and the area is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon filing of the certified copies as directed in Section 6.
