AND UNERRAS, said petition socks to armen the above described property pursuant to Section 414.033 Subdivision (5), of the Minnesota Statutes Annotated, and copies of said netition were served upon the Town of Elk River, and filed with the Minacsota Municipal Commission: on the 9th day of March, 1971;

THEREFORE, the Village Council of the Village of Elk River hereby ordains that the following described property, shall be, and hereby is, declared to be annexed to the Village of Elk River, to-wit:

SCHOOL VIEW 1st ADDITION, according to the plat and survey thereof on file and of record in the office of the Register of Deeds in and for Sherburne County, Minnesota.

This ordinance shall be effective from the date of its passage and publication according to law.
