Ordinance Chapter No 79

An ordinance providing that the City of Little Falls, Minnesota, become subject to the provisions of Chapter ~~two~~ two hundred four of the General Laws of the State of Minnesota for the year 1893, approved April 17<sup>th</sup> 1893 and acts amendatory thereof.

The Common Council of the City of Little Falls, do ordain as follows:

Section 1. That the said city of Little Falls, Minnesota become and said city is hereby declared henceforth to be subject to the provisions of Chapter two hundred four (204) of the General Laws of the State of Minnesota for the year one thousand eight hundred ninety three (A.D. 1893) entitled "An act to grant additional powers to cities of the State of Minnesota and to empower such cities to issue their bonds for certain purposes therein mentioned" approved April 17<sup>th</sup> A.D. 1893 and acts amendatory thereof.

Section 2 All ordinances or parts of ordinances inconsistent with this Chapter are hereby repealed.

Section 3. This ordinance shall take effect from and after its approval publication and filing with the secretary of state of a duly certified copy thereof, accompanied by a statement of the vote thereon with the names of the members of said Council voting for and against said ordinance as provided by section five (5) of said Chapter 204 General Laws

of 1893
