ORDINANCE NO. 687

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE
CITY OF ST. CLOUD.

WHEREAS, after due and careful investigation and consideration,
it is hereby found, determined and declared:

1. That the tracts of land described below are completely surrounded
by land within the municipal limits of the City of St. Cloud.
2. That such lands are urban in character.
3. That the interests of the City of St. Cloud and its inhabitants
will be best served by annexation of said tracts of land to the City of
St. Cloud.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ST. CLOUD HEREBY ORDAINS:

Section 1. That the following described tracts of land situated in
Township 124 North, Range 28 West, Stearns County, Minnesota, be, and
the same hereby are, annexed to the City of St. Cloud, Minnesota, and
declared to be a part thereof:

Tract A

That part of the Southwest Quarter of the Northeast Quarter
and of the Northwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$ and
NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Sixteen (16) described as follows: Beginning
at a point on the East line of said SW $\frac{1}{4}$ NE $\frac{1}{4}$, 12.50 chains (825.0
feet) South of the Northeast corner thereof; thence running South
12.50 chains (825.0 feet), thence West 20 chains (1320 feet) more
or less, to the North-South quarter line of said section, thence
North 12.50 chains (825.0 feet) to a point 12.50 chains (825.0
feet) South of the Northwest corner of said SW $\frac{1}{4}$ NE $\frac{1}{4}$, thence East
20 chains (1320 feet), more or less, to the point of beginning,

And, the Southerly 28 feet of the Easterly 344 feet and the
Westerly 184 feet of the Easterly 528 feet of the North one-quarter
of the South one-half of the Southwest one-quarter of the North-
east one-quarter (NE $\frac{1}{4}$ S $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Sixteen (16), Township
124 North, Range 28 West, Stearns County, Minnesota, and

Lots 16, 17, 18, 19, 20, 21 and the north half of lot 22 and
the platted streets contiguous thereto in Garden Acres according to
the plat and survey thereof on file in the office of the Register of
Deeds, Stearns County, Minnesota.

Tract B

The East 344 feet of the North $\frac{1}{4}$ of the South $\frac{1}{2}$ of the
Southwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 16, excepting therefrom
the South 28 feet thereof.





at a point on the East line of said $SW\frac{1}{2}NE\frac{1}{2}$ 12.50 chains (825.0
feet) South of the Northeast corner thereof; thence running South
12.50 chains (825.0 feet), thence West 20 chains (1320 feet) more
or less, to the North-South quarter line of said section, thence
North 12.50 chains (825.0 feet) to a point 12.50 chains (825.0
feet) South of the Northwest corner of said $SW\frac{1}{2}NE\frac{1}{2}$, thence East
20 chains (1320 feet), more or less, to the point of beginning,

And, the Southerly 28 feet of the Easterly 344 feet and the
Westerly 184 feet of the Easterly 258 feet of the North one-quarter
of the South one-half of the Southwest one-quarter of the North-
east one-quarter ($N\frac{1}{2}S\frac{1}{2}SW\frac{1}{2}NE\frac{1}{2}$) of Section Sixteen (16), Township
124 North, Range 28 West, Stearns County, Minnesota, and

Lots 16, 17, 18, 19, 20, 21 and the north half of lot 22 and
the platted streets contiguous thereto in Garden Acres according to
the plat and survey thereof on file in the office of the Register of
Deeds, Stearns County, Minnesota.

Tract B

The East 344 feet of the North $\frac{1}{2}$ of the South $\frac{1}{2}$ of the
Southwest $\frac{1}{2}$ of the Northeast $\frac{1}{2}$ of Section 16, excepting therefrom
the South 28 feet thereof.

Section 2. This Ordinance shall become effective upon filing a copy thereof with the Minnesota Municipal Commission, the St. Cloud Township Clerk, the Stearns County Auditor, and the Minnesota Secretary of State.




