Six (6), Seven (7) and Eight (8) of Section Two (2),
Township One Hundred Fifty-three (153) North, Range
Forty-three (43) West, bounded as follows:

Beginning at the point of intersection of the
centerline of Minnesota Trunk Highway #59 and the
section line common to said Sections Two (2) and Thirty-
five (35); thence northwesterly along the center line

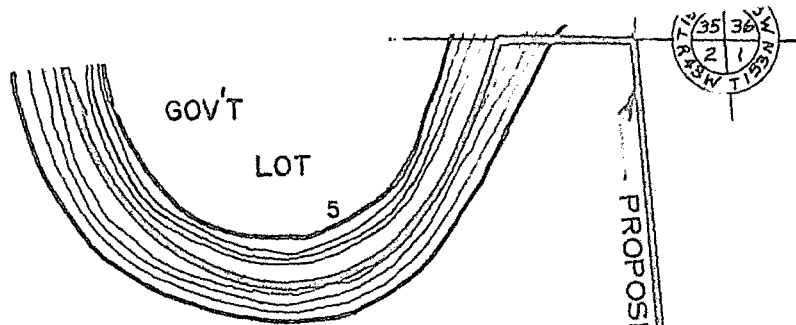

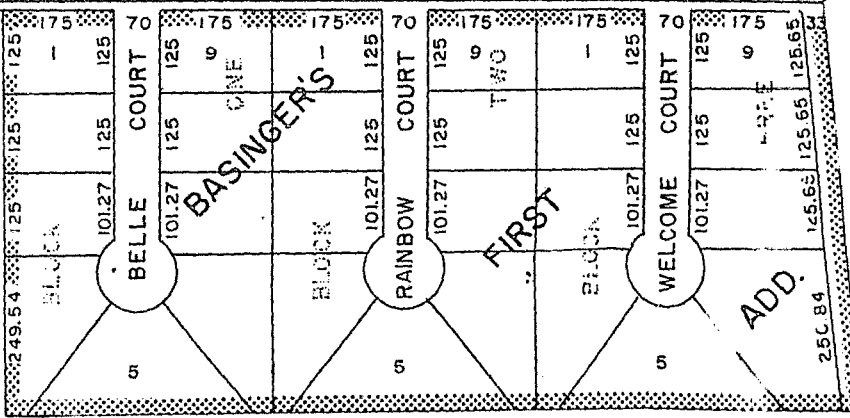
PROPOSED CITY LIMITS



ORDINANCE NO. 373

AN ORDINANCE ANNEXING CERTAIN LANDS
TO THE CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1.

WHEREAS, All of the owners of the following described premises situated in the County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of Government Lots Nine (9) and Eleven (11) of Section Thirty-five (35), Township One Hundred Fifty-four (154) North, Range Forty-three (43) West and Government Lots Six (6), Seven (7) and Eight (8) of Section Two (2), Township One Hundred Fifty-three (153) North, Range Forty-three (43) West, bounded as follows:

Beginning at the point of intersection of the centerline of Minnesota Trunk Highway #59 and the section line common to said Sections Two (2) and Thirty-five (35); thence northwesterly along the center line of said Trunk Highway #59 a distance of 960.46'; thence northeasterly at right angles at 90° to said Highway centerline a distance of 525'; thence southeasterly along a line parallel to said Highway centerline a distance of 1488.14' to said common section line; thence East along said section line to the centerline of the Red Lake River; thence easterly along said centerline to an intersection with said common section line; thence East along said section line to the northeast corner of said Section Two (2); thence South along the East line of said Section Two (2) to the southeast corner of said Government Lot Six (6); thence West along the South line of said Government Lots Six (6), Seven (7) and Eight (8) to an intersection with the centerline of Minnesota Trunk Highway #59; thence northwesterly along said Highway centerline to the point of beginning; excepting therefrom the South two (2) rods of said Government Lots Six (6), Seven (7) and Eight (8); containing 120 acres more or less.

have petitioned to the City Council to have such land included within the municipality and have filed copies of said Petition with the Municipal Commission of the State of Minnesota, with the Town Board of the North Township of North and with the County Board of the County of Pennington, State of Minnesota and

WHEREAS, the above described property abuts upon the boundaries of the City of Thief River Falls, and

WHEREAS, No objections to the proposed annexation have been submitted,

NOW, THEREFORE, It is hereby determined that the annexation of said premises will be to the best interest of the City of Thief River Falls and of the territory affected and the above described premises are hereby declared annexed to the City of Thief River Falls.

Section 2.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, the Town Clerk, the Pennington County Auditor and the Secretary of State of the State of Minnesota.
