ORDINANCE NO. 107

AN ORDINANCE RELATING TO ANNEXATION

The Village Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory


The following-described territory is hereby annexed to the Village of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Tract of land situated in Section Four (4), Township One Hundred Five (105), (Mountain Lake Township), Range Thirty-Four (34), Cottonwood County, Minnesota, described as follows:
Commencing at the Northeast (NE) corner of Lot Three (3), Block Two (2), Klein's Subdivision No. Two (2), this being the place of beginning; thence West (W) parallel with and Thirty-Three (33) feet South (S) from the North (N) boundary line of said section, a distance of One Thousand Six Hundred Sixty-One and 25/100 (1,661.25') feet; thence at right angle South (S) and parallel with the East (E) boundary line of said section, a distance of Three Hundred Thirty (330) feet; thence at right angle East (E) and parallel with North (N) boundary line of said section, a distance of One Thousand Six Hundred Sixty-One and 25/100 (1,661.25') feet, more or less, to the Southeast (SE) corner of said Lot Three (3), Block Two (2), Klein's Subdivision No. 2, thence North (N) along the East (E) boundary line of said Lot Three (3), Block Two (2), Klein's Subdivision No. 2, a distance of Three Hundred Thirty (330) feet, more or less, to the place of beginning; (containing approximately 12½ acres)
(Including abutting roads and rights-of-way; which tract abuts upon the Village of Mountain Lake.)

Section 2. Effective Date

This Ordinance becomes effective on the date of its publication.
