ORDINANCE NO. 1971-B

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ST. JOSEPH  
TO INCLUDE CERTAIN UNINCORPORATED PLATTED LANDS ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated January 7, 1971, requesting annexation of  
the territory hereinafter described was duly presented to the Council on the 7th  
day of January, 1971; and

WHEREAS, the quantity of land embraced within the area described in the  
petition and bounded as described is 4.27 acres of platted land, no part of  
which is included within the limits of any incorporated city, village or  
borough; and

WHEREAS, the petition was signed by all of the owners of said tract; and

WHEREAS, no objections to the annexation have been received from the Town  
Board, the County Board, or the governing body of any municipality whose  
boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the Village limits  
at the northerly boundary thereof;

THE COUNCIL OF THE VILLAGE OF ST. JOSEPH, MINNESOTA, ORDAINS:

Section 1. The Village Council determines,

a. That the annexation would be to the best interest of the Village  
and the territory affected;

b. That the territory described therein abuts upon the Village  
limits and is about to become urban or sub-urban in character;

c. That none of said territory is now included within the limits of  
any city, village or borough.

Section 2. The corporate limits of the Village are hereby extended to  
include the platted land described as follows and the same is hereby annexed  
to and included within the Village as effectually as if it had originally been  
a part thereof;

Lots One (1), Two (2), and Three (3) of Block One (1), and Lots Five (5)  
Six (6), Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11), Twelve  
(12), Thirteen (13) and Fourteen (14), of Block Two (2) all in Loso's  
6th Addition to the Township of St. Joseph, and also the fee title to  
that part of the adjacent streets and alleys in Loso's 6th Addition to  
the Township of St. Joseph.

Section 3. Filing. The Village Clerk is hereby directed to file certified

copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Register of Deeds.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
