ORDINANCE /126

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF  
THE CITY OF MONTGOMERY TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED  
LAND NOT EXCEEDING TWO HUNDRED (200) ACRES IN AREA AND Lying UPON THE  
CITY LIMITS

WHEREAS, the Montgomery Golf and Recreation Club, Inc., is the sole owner of  
the following described tract of land situated in Le Sueur County, Minnesota;

Commencing at the center of Section Three (3), Township One Hundred  
Eleven (111), Range Twenty Three (23), thence West on said center  
line 837 foot to the Northwest corner of Lot Five (5), Block One (1),  
Sunset View Addition, City of Montgomery, thence North 33 feet,  
thence East 100 feet, thence North 150 feet, thence East 1/2 foot 4  
inches, thence Northeasterly to a point 11 feet 4 inches directly  
East of the last given point and 207 feet North of said center line,  
thence North 49.50 feet, thence East to the East line of the Northeast  
Quarter of said Section, thence South 696.50 feet to the place of  
beginning.

WHEREAS, a certain petition of the Montgomery Golf and Recreation Club, Inc.,  
dated November 23, 1970, requesting annexation of the territory above described  
was duly presented to the Common Council of the City of Montgomery on the 23rd day  
of November, 1970; and

WHEREAS, copies of the Petition to Annex covering the above described pro-  
perty have been filed with the Minnesota Municipal Commission, the County Board of  
Commissioners of Le Sueur County and the Town Board of Montgomery Township and said  
Town Board has waived its right to object to this annexation by action dated  
November 23, 1970, and

WHEREAS, The Common Council of the City of Montgomery hereby determines that  
this property is so located and conditioned as to be properly subject to Municipal  
Government, is about to become urban or suburban in character and that annexation  
of the same would be in the best interest of the City and the above described pro-  
perty.

NOW THEREFORE, The Common Council of the City of Montgomery, Minnesota, does  
ordain:

1. That the following described property is hereby annexed to the City of  
Montgomery, Minnesota, and the corporate limits of said City of Montgomery  
are hereby extended to include the above described unplatted lands as  
effectually as if it had originally come a part thereof;

Commencing at the center of Section Three (3), Township One  
Hundred Eleven (111), Range Twenty Three (23), thence West on

said corner Thence North 45 degrees East 40 feet, thence South 45 degrees West 100 feet, thence North 150 feet, thence North 30 degrees East 40 feet, thence North 150 degrees East 40 feet, thence South 45 degrees West 100 feet, thence South 45 degrees East 40 feet, thence North 150 degrees East 40 feet, thence North 30 degrees East 40 feet, thence South 45 degrees West 100 feet, thence North 150 degrees East 40 feet, thence South 45 degrees West 100 feet to the place of beginning.

2. This ordinance shall go into effect on the passing, publication and posting and upon filing of certified copies of said ordinance with the Minnesota Judicial Department, the City of Le Sueur County Auditor, the Le Sueur County Auditor, the Secretary of State of the State of Minnesota and the Register of Deeds of Le Sueur County.
