21 **ORDINANCE NO. 92.**

22 AN ordinance adopting the provisions of chap-
23 ter 204 of the General Laws of the state of
Minnesota for the year, A. D. 1893, entitled
"An Act to Grant Additional Powers to Cities
of the State of Minnesota and to Empower
Such Cities to Issue Their Bonds for Certain
Purposes Therein Mentioned."

The City Council of the city of Albert Lea do
ordain:

24 Section 1. That chapter 204 of the General
Laws of the State of Minnesota for the year A.
D. 1893, entitled "An Act to Grant Additional
Powers to Cities of the State of Minnesota, and
to Empower Such Cities to Issue Their Bonds
for Certain Purposes Therein Mentioned," be
25 and the same hereby is adopted by the city of
Albert Lea, the purposes of this ordinance be-
ing to subject the city of Albert Lea to each and
26 all of the provisions of said act in the manner
therein provided.

27 Section 2. That immediately upon the pas-
sage and publication of this ordinance the city
clerk of the city of Albert Lea, shall forward to
and file in the office of the secretary of state for
the state of Minnesota a certified copy of this
ordinance together with a statement of the
28 vote thereon agreeably to the provisions of said
chapter 204 of the General Laws of the state of
Minnesota for the year A. D. 1893.

29 Section 3. This ordinance shall take effect
and be in force from and after its publication.
Passed May 12, A. D. 1899.
