Beginning at a point on the North line of the Northwest quarter of Section 24, Township 103 North, Range 16 West of the 5th P.M., in Mover County, Minnesota, which point is 947.2 feet East of the Northwest Corner of said Section 24, a distance of 60 feet; thence South on a line parallel with the West line of said Section 24, a distance of 73 feet; thence West on a line parallel with the North line of said Section 24, a distance of 60 feet; thence Worth on a line parallel with the North line of said Section 24, a distance of 60 feet; thence Worth on a line parallel with the West line of said Section 24, a distance of 73 feet to the place of beginning, subject to highway easement on the North side thereof.

Section 3. Filing. The Village Clark is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the Gounty Auditor.
