ORDINANCE NO. 65

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ISANF, ISANTI COUNTY, MINNESOTA, TO INCLUDE CERTAIN PROPERTY OWNED BY SAID VILLAGE.

THE VILLAGE COUNCIL OF ISANTI, MINNESOTA, ORDAINS:

Section 1. Territory Annexed. The corporate limits of the Village of Isanti, Isanti County, Minnesota, are hereby extended to include the property hereinafter described, which property abutts the Village of Isanti, is not included in any other municipality and is now owned by the Village of Isanti, The description of the land hereby annexed by this Ordinance is as follows, to-wit:

That certain parcel of land lying and being in the County of Isanti and State of Minnesota described as follows, to-wit:

The West 180 feet of the East 935 feet of the North 767.5 feet, as measured along the north and east line thereof, of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{3}$ of SE $\frac{1}{3}$) of Section Thirty (30), Township Thirty-five (35), Range Twenty-three (23).

Section 2. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance in the office of the Secretary of State. of Minnesota, the Minnesota Municipal Commission, the Isanti County Auditor, and the Township Clerk of Isanti Township, Minnesota.

Section 3. Effective Date of Annexation. Annexation shall be complete and final upon filing Certified copies of this Ordinance as directed in Section 2, hereof.
