AN ORDINANCE OF ANNEXATION

(Part of the S $\frac{1}{2}$  of the SW $\frac{1}{4}$ , Section 14, Township 109, Range 40, West of the Fifth Principal Meridian, County of Lyon, State of Minnesota.)

The City Council of the City of Tracy, do ordain as follows:

1. That pursuant to and in accordance with Minnesota Statutes 414.033, the City of Tracy, Minnesota, hereby annexes to said City of Tracy, the following property located in the County of Lyon, State of Minnesota:

All that part of the South Half of the Southwest Quarter (S $\frac{1}{2}$ SW $\frac{1}{4}$ ), Section Fourteen (14), Township One Hundred Nine (109), Range Forty (40), lying south and east of the following described lines:

Beginning at a point 1290.6 ft. east of the southwest corner of said Southwest Quarter (SW $\frac{1}{4}$ ); thence north 721.6 ft, to a point; thence east, parallel to the south line of said Southwest Quarter (SW $\frac{1}{4}$ ), and there terminating, excepting those parts thereof already annexed to the City of Tracy, Lyon County, Minnesota.

2. That the perimeter of the area to be annexed is 60% or more bordered by the City of Tracy.

3. That on August 17, 1971, the City of Tracy caused to be served upon the chairman of the Town Board of the Town of Monroe, County of Lyon, State of Minnesota, Notice of Intent to Annex Certain Land.

4. That said Town of Monroe by and through its duly elected Town Board, and pursuant to a duly called meeting of said Board held on the 31st day of August, 1971, acted to waive its right to object to said annexation of said property, as provided by Minnesota Statutes 414.033, subdivision 3.

5. That this ordinance shall be published once in the official newspaper of the city following its adoption by the Council in accordance with the City Charter.

6. That, immediately following such publication, the City Recorder is hereby authorized and directed to file a

certified copy of this ordinance with each of the following:

- a. Minnesota Municipal Commission.
- b. Town Clerk of the Town of Monroe.
- c. Lyon County Auditor.
- d. Secretary of State of the State of Minnesota.
