ORDINANCE NO. 69

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ISANTI, ISANTI COUNTY, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS, a certain petition dated the 16th day of November, 1970 requesting annexation of the territory described below, was duly presented to the council and filed in the office of the Village Clerk on November 17, 1970; and

WHEREAS, said petition for annexation was duly signed by all of the owners of the property described below, and

WHEREAS, a true and correct copy of said petition for annexation was filed in the office of the Township Clerk of the Township of Isanti on November 28, 1970, and in the office of the County Auditor in and for Isanti County, Minnesota, on November 18, 1970, the said Township and County being the same in which all of the land to be annexed is located; and

WHEREAS, a true and correct copy of said petition for annexation, together with the required certificate of filing the same and the other required items, have been duly filed with the Minnesota Municipal Commission and copies of the Certificate of Filing have been duly mailed to the Isanti County Auditor and the Minnesota Secretary of State; and

WHEREAS, more than 30 days have elapsed since said petition and the other required papers were duly filed, and all other legal requirements as to filing and certification have been met, and certain objections to such annexation made by the Township of Isanti have been withdrawn, and there are now no written objections to the annexation from any municipal subdivision or person that have been filed or submitted to the said Minnesota Municipal Commission or the Village of Isanti; and

WHEREAS, the Village Council has determined that the annexation of the territory hereinafter described will be to the best interest of the municipality and of the territory affected, and that said territory is so conditioned as properly to be subjected to Village government:

NOW THEREFORE, THE VILLAGE COUNCIL OF ISANTI ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the Village of Isanti and is so conditioned as to properly be subjected to Village Government, and that the annexation thereof would be to the best interest of the Village of Isanti and the territory affected.

Section 2. Territory Annexed. The corporate limits of the Village of Isanti are hereby extended to include the territory described as follows, to-wit:

The West 396 foot of the East 935 foot of the North 1699.5 feet, as measured along the North and East lines thereof, of the West Half of the Southeast Quarter (W $\frac{1}{2}$  of SE $\frac{1}{4}$ ) of Section Thirty (30), Township Thirty-five (35), Range Twenty-three (23), excepting, however, the West 180 foot of the East 935 foot of the North 767.5 feet, as measured along the north and east lines thereof, of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of said Section Thirty (30), Township Thirty-five (35), Range Twenty-three (23).

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance in the Office of the Secretary of State, in the Office of the Minnesota Municipal Commission, and the Office of the Isanti County Auditor, all pursuant to Minnesota Statutes Annotated Section 414.03, as amended.

Section 4. Effective Date of Annexation. Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section 3, hereof.
