Section 1. Territory Annexed. The corporate limits of the Village of Cambridge, Isanti County, Minnesota, are hereby extended to include the property hereinafter described, which property abuts the Village of Cambridge, is not included in any other municipality, and is now owned by the Village of Cambridge. The description of the land hereby annexed by this Ordinance is as follows, to-wit:

> Government Lots Six (6), Eight (3), and Nine (9), and the Northwest Quarter of the Northwest Quarter (NNA of NWA) in Section Thirty-two (32), Township Thirty-six-(36), Range Twenty-three (23);

Government Lot Five (5), in Scction Thirty-two (32), Township Thirty-Bix (36), Range Twenty-three (23), excepting that part thereof known as the Three Islands, formed by the Rum River, setting back and nearly forming an island, and all of said Lot Five (5), lying West of said island, said exception containing 11 acres.

Government Lot Seven (7) in Section Thirty-two (32), Township Thirty-six (36), Range Twenty-three (23), excepting therefrom the West 675 feet of the South 76255set thereof;

The East 700 feet (E. 700') of the East Half of the Northeast Quarter (E4 of NE4) of Section Thirty-one (31), Township Thirty-six (36), Range Twenty-three (23), excepting therefrom the South 762 feet thereof.
