



ORDINANCE NO. 103

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington, Do Ordain:

Section 1. Petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following real estate, to have such property included within the City of Worthington, Minnesota:

That part of the Southeast Quarter (SE $\frac{1}{4}$) of Section 27, and the Southwest Quarter (SW $\frac{1}{4}$) of Section 26, all in Township 102, Range 40, Nobles County, Minnesota, described as follows: Beginning at the Southeast corner of the Plot of Blocks 13 and 14, Ludlow Acres, an Addition to the City of Worthington; thence North 89° 37' West along the South line of said plot, a distance of 329.00 feet; thence South 80° 47' West, along the South line of said plot a distance of 162.4 feet; thence North 89° 37' West, along the South line of said Plot, a distance of 172.00 feet, to the Southwest corner of Lot 7 of Block 13 of said plot; thence North 80° 18' East, along the West side of said Lot 7, a distance of 88.1 feet, to the Northwest corner of said Lot 7; thence South 60° 25' West, along the South line of Indian Hill Road, a distance of 346.70 feet, to the East line of Pleasant Street; thence North 89° 21' West, a distance of 70.00 feet, to the West line of Pleasant Street; thence South 80° 35' West, along a line extended from the west line of Pleasant Street, a distance of 410.04 feet; thence South 89° 37' East, a distance of 221.21 feet; thence North 60° 25' East, a distance of 424.23 feet; thence South 89° 37' East, a distance of 435.46 feet; thence North 80° 18' East, a distance of 310.00 feet, to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 8.7 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on September 9, 1971, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the City are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and Township Clerk.

Section 7. This ordinance shall take effect upon its passage and publication and upon filing of the certified copies as directed in Section 6.
