Pursuant to Chapter 951 of the 1971 Minnesota Session Laws and Minnesota Statutes 487.01, Subd. 9, Part 1, you are hereby advised that I consent to act as County Court Judge for Grant County and the County Court District consisting of Douglas and Grant Counties. Said Jurisdiction is to be assumed by me on December 27, 1971. Douglas County and Grant County were formerly in a District consisting of Douglas, Pope and Grant Counties, and by concurrent resolutions of the respective county boards, was divided into single county courts. Subsequently, the County Boards of Grant County and Douglas County resolved to merge into the existing Douglas and Grant County District.






