

WHEREAS, Senate File #266 was enacted into law by the Legislature of State of Minnesota and signed by the governor creating a County Court System, and

WHEREAS, Section 45 of said bill provides the following. "However the effective date of this act maybe advanced to any date not prior to July 1, 1971 for any County Court district upon the concurrence of all the County Boards in such district", and

WHEREAS, A County Court district was created by said bill, which include the counties of Pine, Chisago and Isanti with two judges to serve from the District, and

WHEREAS, the bill makes it mandatory that the bill be put into effect by July 1, 1972, and

WHEREAS, the County Commissioners of the County of Pine believes it to be beneficial to County of Pine to advance the effective date of the bill, to January 1, 1972 pursuant to Section 45.

NOW HEREBY BE IT RESOLVED by the County Board of County of Pine that the said County Court district commence operating and be put into effect on January 1, 1972.
