WHEREAS, The Minnesota State Legislature pursuant to Laws of 1971, Chapter 951, has provided for a county court system in the State of Minnesota, and

WHEREAS, Said law provides that Carlton and Aitkin Counties shall comprise one district unless by concurrence of both county boards said counties shall comprise separate districts, and

WHEREAS, The County Board of Carlton County has by resolution adopted October 13, 1971, resolved that it would be preferable for Carlton County to maintain a separate court system.

NOW THEREFORE, BE IT RESOLVED, by the County Board of Aitkin County that said Board concurs with the County Board of Carlton County and that Aitkin County shall comprise a separate judicial district under the provisions of Laws of 1971, Chapter 951.

BE IT FURTHER RESOLVED, That the County Auditor is hereby directed to send copies of this resolution to the County Auditor of Carlton County and to the Secretary of the State of Minnesota.



Wadena County Court District.


