WHIREAS, The City of Shekopes by purebase is now the fee owner of the land hereinafter described and it is to the best interest of the City and all parties concerned that said land hereinafter described to annexed to the City of Shekopes.

THEREFORE, The Common Common of the City of Shakepee deep ordains SECTION I: Amongston by Ordinance

That the City of Shakopee does hereby annea by ordinance purposent to 414.033 the following described land acquired by the City of Shakopee by purchase and presently lying within the Township of Jackson, Scott County, Minneacta which land is more particularly described as follows, to-with

A. The Southeast Quarter of the Southeast Quarter of Section 11, Township 115, Range 23; Scott County, Minnesota, except the South 10.0 feet thereof, containing approximately 40.59 acros.

B. The Northwest Quarter of the Southwest Quarter of Section 12, Township 115. Range 23.
