#### ORDINANCE NO. 42

AN ORDINANCE ANNEXING THE SOUTHWEST ONE-QUARTER OF THE NORTHEAST ONE-QUARTER  $(SW_{4}^{1}NE_{4}^{1})$  OF SECTION NINETEEN (19), TOWNSHIP 159 NORTH, RANGE 45 WEST, EXCEPTING THEREFROM, THE EASTERLY TEN (10) RODS THEREOF, AND CONTAIN-ING 35 ACRES, MORE OR LESS, TO THE VILLAGE OF KARLSTAD, KITTSON COUNTY, MINNESOTA.

#### THE VILLAGE COUNCIL OF KARLSTAD ORDAINS:

Section 1. That the following property shall be annexed pursuant to M. S. A. 414.033 to the Village of Karlstad, Minnesota:

> The Southwest one-quarter of the Northeast onequarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Nineteen (19), Township One Hundred Fifty-nine (159) North, Range Forty-five (45) West, EXCEPTING THEREFROM, the Easterly Ten (10) rods thereof, and containing Thirty-five (35) acres, more or less.

Section 2. That it will be to the best interest of the Village of Karlstad, Minnesota, and the territory affected that such land be annexed to the Village of Karlstad, Minnesota.
