AFFIDAVIT OF PUBLICATION

STATE OF MINNESOTA County of Dakota

JOYCE L. CLAY, being duly sworn, on oath says she is and during all the times herein stated has been the publisher and printer of the newspaper known as Dakota County Tribune and has full knowledge of the facts herein stated as follows: Said newspaper is printed in the English language in newspaper format and in column and sheet form equivalent in printed space to at least 900 square inches. Said newspaper is a weekly and is distributed at least once each week. Said newspaper has 50 per cent of its news columns devoted to news of local interest to the community which it purports to serve and does not wholly duplicate any other publication and is not made up entirely of patents, plate matter and advertisements. Said newspaper is circulated in and near the municipality which it purports to serve, has at least 500 copies regularly delivered to paying subscribers, has an average of at least 75 per cent of its total circulation currently paid or no more than three months in arrears and has entry as second-class matter in its local post-office. Said newspaper purports to serve the Village in the County of Dakota and it has its known offices of issue in the Villages of Farmington, Rosemount, Burnsville, Apple Valley, and Lakeville established and open during its regular business hours for the gathering of news, sale of advertisements and sale of subscriptions and maintained by the managing officer of said newspaper or persons in it's employ and subject to her direction and control during all such regular business hours and at which said newspaper is printed. Said newspaper files a copy of each issue immediately with the State Historical Society. Said newspaper has complied with all the foregoing conditions for at least two years preceding the day or dates of publication mentioned below. Said newspaper has filed with the Secretary of State of Minnesota prior to January 1, 1966 and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the managing officer of said newspaper and sworn to before a notary public stating that the newspaper

is a legal newspaper. She further states on oath that the printed legal hereto attached as a part hereof was cut from the columns of said newspaper, and was printed and published therein in the English language, once each week successive weeks; that it was first so published day of December on Thursday, the 231d _ 19<u> 7 /</u> and was thereafter printed and published on every Thursday to and including Thursday _day of December _ 1971 and that the following is a printed copy of the lower case alphabet from A to Z, both inclusive, and is hereby acknowledged as being the size and kind of type used in the composition and publication of said notice, to wit; defghijklmnopgrstuvwxyz Subscribed and sworn to before me this _

MINNESOTA STATE JUNIOR COLLEGE BOARD

PARKING AND TRAFFIC REGULATIONS FOR INVER HILLS STATE JUNIOR COLLEGE AND PENALTY FOR THE VIOLATIONS THEREOF.

Do it ordained by the Minnesote State Junior College Board.

Section I - PARKING AND TRAFFIC RULES AND REGULATIONS ADOPTED.

The Minnesota State Junior College Board, pursuant to Minnesota Statute 169.66 and Minnesota Session Laws Chapter 965 Section 20 (1971), hereby adopts the following Parking Traffic Rules and Regulations to be administered and enforced on the property of Inver Hills State Junior College:

- 1. Only those vehicles belonging to students or employees of Inver Hills State Junior College or to other persons having a purpose or function at the college may park on college property.
- 2. Parking is prohibited on college property in the evening after 11:30 p.m. with the following exceptions:
 - a. Vehicles that are owned or leased by the College.
 - b. Vehicles belonging to those persons covered by the above regulation Number 1 who are in attendance at an activity which is not completed before 11:00 p.m. and which activity has the written approval of the college President.
 - 1. When approved activities are not completed until 11:00 p.m. or later, vehicles are to be removed from college property within 30 minutes after the completion of the activity.
 - c. Vehicles belonging to college employees whose hours of employment require their presence at the college between the hours of 11:00 p.m. and 7:00 a.m.
- J. Parking is prohibited on college roadways, sidewalks, landscaped areas, safety zones, loading zones, within ten feet of intersections, adjacent to yellow curbs, and in areas where parking is expressly prohibited by signs. Exceptions to this regulation are as follows:

- a. College-owned vehicles, when being used in the performance of work on college property.
- b. Vehicles making delivery of goods to the college may park in the loading zones during required delivery time.
- c. Vehicles are permitted to park adjacent to the east curb of the entrance driveway (right-hand curb when extering the college property) except where curb is yellow or restricted by a No Parking sign.
- 4. Parking in a restricted area shall be limited to those persons who have been issued a Special Permit for parking in a restricted area. Special Permits are issued by the Dam of Students in the form of a card or sticker which must be displayed when the vehicle is parked in the restricted area.
- 5. Parking lanes are designated by painted yellow lines. Adequate space has been provided between each set of yellow lines to park an automobile. Parking is restricted to a maximum of one parking lane per vehicle. Parking on yellow lane lines or parking in a position which occupies more than one parking lane is prohibited.
- 6. All vehicles are required to follow directional arrows and signs to gain entrance to and exit from parking areas.
- 7. Meximum speed of vahicles on college property shall be 30 miles per hour, and such lesser speeds as may be indicated by posted signs.
- 8. The dumping or depositing of any refuse on college property is prohibited.
- 9. The regulatory provisions of Minnesota Statutes 1961 Chapter 169, as aneaded, are hereby adopted as traffic regulation controlling the use of parking facilities and private roads, readways and college property on property owned, leased, occupied or operated by the Inver Hills State Junior College.
- 10. No person shall drive or operate a snowmobile on property owned, leased, occupied or operated by the Inver Kills State Junior College without the express written permission of the President of the college or his designate.

Section II - ENFORCEMENT

Every sheriff, constable, police officer, or other peace officer shall see that all rules of this regulation are obeyed and shall arrest and prozecute offenders.

Saction III - PENALTIES

Any person violating any provision of this regulation shall be guilty of a petty misdemeanor. Any fines paid as a result of a violation of this ordinance shall be paid to the Village of Inver Grove Heights in the same manner as fines received from the violation of Village Ordinances.

Section IV - EFFECTIVE DATE

The regulation shall be in full force and effect from and after its adoption according to law.
