Dear Doctor Lawson:

In accordance with M.S. 1969, Section 4.07, I authorize the Minnesota State Board of Health (Minnesota State Department of Health) to receive United States Government funds made available through the Northlands Regional Medical Program, Inc. for the following projects:

- 1) Innovations in Public Health Nursing. Duration of the project to be for one year, beginning April 1, 1972. A budget of approximately \$23,570 is anticipated.
- 2) Assignment of a Nurse to a "Doctorless Town." Duration of the project to be for one year, beginning at a yet unspecified date. A budget of approximately \$12,000 is anticipated.
- 3) Statewide Emergency Medical Services Plan. Duration of the project to be for a period of four years, beginning July 1, 1972. A budget of the following is anticipated: First year (\$63,800); second year (\$378,950); third year (\$298,650); fourth year (\$269,650).
- 4) Upgrading the Quality of Clinical Laboratory Tests by Improving Performance of Laboratory Personnel in Non-Urban Hospitals Through Continued Education. Duration of the project is for a three-month period, beginning April 1, 1972. A budget of approximately \$5,667 is anticipated.
