ORDINANCE NO. 32

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF FREEBORN TO INCLUDE CERTAIN (PLATTED) (UNPLATTED) LAND

FEB 22 1972

Introduced by Robert Miller

WHEREAS, a Petition has been filed with the governing body of the Village of Freeborn, Minnesota, signed by the owner of the following described real estate to have such land included within the Village of Freeborn, Minnesota:

Commencing at a point, which point is located as follows: Extending the East line of Lot 5, Block 70, Village of Freeborn, Minnesota, South to the intersection of the North line of the right-of-way of State Aid Road No. 15 and outlot of "Auditor's Plat Book, 1895" on file in the office of the Register of Deeds of Freeborn County; thence Southeasterly along said North right-of-way of said State Aid Road No. 15, 220 feet to the point of beginning; thence Northeasterly 100 feet; thence Scutheasterly 180 feet; thence Southwesterly to the North right-of-way line of State Aid Road No. 15; thence Northwesterly along said right-of-way line of State Aid Road No. 15 to the point of beginning

The quantity of land embraced within the foregoing description, and bounded as described, is 2 acres, more or less.

THE VILLAGE OF FREEBORN DOES ORDAIN:

Section 1. That the annexation will be to the best interests of the Village of Freeborn and to the territory affected; that the territory described herein abut upon the Village and is so conditioned as properly to be subjected to Village Government.

Sec. 2. That the property hereinbefore described be and the same is hereby annexed to, and included in the Village of Freeborn as effectually as if it had originally been a part thereof.

Sec. 3. That this ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Commission, the Clerk of Freeborn Township, the County Auditor and the Secretary of State and from and after its passage and publication.
