ORDINANCE NO. 104

AN ORDINANCE CHANGING THE REGULAR VILLAGE ELECTION DATE TO THE FIRST TUESDAY AFTER THE FIRST MONDAY IN NOVEMBER.

WHEREAS, The Village of Magnolia, Minnesota, has held its annual regular village elections on the first Tuesday after the first Monday in December of each year;

AND WHEREAS, It is believed to be in the best interests of the Village of Magnolia, Minnesota to change the annual village election date to the first Tuesday after the first Monday in November of each year pursuant to authority set forth in Minnesota Statutes 205.07.

THE VILLAGE COUNCIL OF MAGNOLIA, MINNESOTA, ORDAINS:

Section 1. The regular village election of the Village of Magnolia, Minnesota, shall be held annually on the first Tuesday after the first Monday in November of every year.

Section 2. Upon passage and publication of this ordinance, the Village Clerk is directed to immediately notify the County Auditor for Rock County, Minnesota and the Secretary of State for the State of Minnesota of the change of date of the regular village election from the first Tuesday after the first Monday in December in every year to the first Tuesday after the first Monday in November of every year.

Section 3. This ordinance takes effect upon its passage, publication and notification to the County Auditor and Secretary of State as directed in Section 2, above.
