## ORDINANCE NO. 1972-1

AN ORDINANCE ANNEXING C E R T A I N U N I N CORPORATED PROPERTY IN THE TOWNSHIP OF HASSAN TO THE VILLAGE OF ROGERS

WHEREAS; all of the property owners of the unplatted land hereinafter described, being in the Township of Hassan, County of Hennepin and State of Minnesota have petitioned the Council of the Village of Rogers requesting the annexation of such territory; and whereas no written objections have been submitted, and whereas this Council determines that the annexation is in the best interests of the Village and of the territory affected.
