ORDINANCE NO. 161

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF AITKIN, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS,

WHEREAS, a certain petition dated September 30, 1971, requesting the annexation of the territory hereinafter described, was duly presented to the Council on the 6th day of October, 1971; and

WHEREAS, the quantity of land embraced within the area described in the petition consists of approximately 180 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by a majority of the property owners in number within the area to be annexed; and

WHEREAS, no written objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the existing village limits at and along the west boundary thereof;

THE COUNCIL OF THE VILLAGE OF AITKIN, MINNESOTA, ORDAINS:

Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the municipality and of the territory affected; (2) that the territory described herein abuts upon the existing village limits to the west and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the Village of Aitkin are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

That part of the Southeast Quarter of Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) lying and being West of the existing Aitkin Village limits and South of C.S.A. Highway Number 15, and the South Four Hundred Seventeen (417) feet of the Southwest Quarter of Southwest Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Twenty-three (23); and

all of Section Twenty-six (26) lying and being West of the existing Aitkin Village limits and North of County Road Number 77; and

that part of the East One-half of the Northeast Quarter (E $\frac{1}{2}$ of NE $\frac{1}{4}$) lying and being North of County Road No. 77, in Section Twenty-seven (27),

All of the aforesaid property being in Township Forty-seven (47), Range Twenty-seven (27), and including all existing roads, easements, right-of-way and utilities, public or private.

Section 3. Filing. The Village Clerk is hereby directed to file a copy of this Ordinance with the Minnesota Municipal Commission, the Clerk of the Town of Aitkin, the Aitkin County Auditor, and the Minnesota Secretary of State.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the copies thereof as aforesaid.
