We, the undersigned inspectors, hereby certify and return that we have canvassed the ballots cast at the annual village election held at Callaway in the County of Becker and State of Minnesota, on the 12 th day of March 1918., the time and place specified in the election notice, to vote for or against the detachment of the unplatted lands described below; from the incorporated Village of Callaway, in the County of Becker and State of Minnesota, and to restore same to the townships of Callaway and Richwood, in said county and state.
