RESOLUTION NO. 4664

RESOLUTION APPROVING THE PETITION FOR ANNEXATION OF CERTAIN LANDS TO THE CITY OF STILLWATER, MINNESOTA.

WHEREAS, it is necessary, advisable, and in the best public interest that the City of Stillwater, Minnesota, approve the petition to annex the following described property to the City of Stillwater, Minnesota, to-wit:

All that part of the South Half of the Southeast Quarter (S $\frac{1}{2}$ of SE $\frac{1}{4}$) of Section Thirty (30), T20N, R20W, Washington County, Minnesota, described as follows:

Beginning at the northeast corner of the West 330 feet of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 30, T30N, R20W, Washington Co., Minnesota; thence westerly along the North line of the S $\frac{1}{2}$ of SE $\frac{1}{4}$ of said Sec. 30, being also the North line of Lot 12, Blk. 1 of "Cochran's Long Lake", on an assumed bearing of North 88° 10'45" West for 343.48 feet to the centerline of Mid Oaks Avenue North; thence South 1°15'55" East along said centerline of Mid Oaks Ave. N. for 24.12 feet; thence southerly along said centerline of Mid Oaks Ave. No. on a tangential curve, concave to the northeast having a central angle of 30°08'30" and radius of 315.66 feet, for 166.06 feet; thence tangentially South 31°24'25" East along said centerline of Mid Oaks Ave. N. for 245.38 feet; thence southerly along said centerline, on a tangential curve, concave to the West, having a central angle of 55°33'35" and radius of 151.86 feet, for 147.26 feet; thence tangentially South 24°09'10" West along said centerline, for 521.74 feet; thence southwesterly along said centerline, on a tangential curve, concave to the northwest, having a central angle of 33°42'10" and radius of 231.10 feet, for 135.94 feet; thence tangentially South 57°51'20" West along said centerline, for 81.03 feet; thence westerly along said centerline, on a tangential curve, concave to the North, having a central angle of 41°31'30" and radius of 105.51 feet, for 76.47 feet; thence tangentially North 80°37'10" West along said centerline of Mid Oaks Ave. N. for 99.30 feet to the radius point of a 60 foot radius cul-de-sac; thence South 3°39'19" West along the westerly line of Lot 8, Bl. 1 of said "Cochran's Long Lake" and its northerly projection, for 161.10 feet to the South line of said Sec. 30; thence South 88°07'42" East along said South line of Sec. 30 for 690.91 feet to the southeast corner of said West 330 feet of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 30; thence North 0°54'04" East along the East line of said West 330 feet of SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 30 for 1323.78 feet to the point of beginning.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Stillwater, Minnesota, that the above described petition for annexation be, and it is hereby, approved.
