



ORDINANCE NO. 219

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE
VILLAGE OF FOREST LAKE

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village or borough, and

WHEREAS, the owners of the territory described below Petition the Village Council of the Village of Forest Lake, on June 28, 1971, to annex the territory described below to the Village of Forest Lake, and

WHEREAS, by Resolution adopted by the Village Council of the Village of Forest Lake, on June 28, 1971, and served by mail upon the Washington County Board of Commissioners, Forest Lake Town Board and Minnesota Municipal Commission, on July 15, 1971; the said Village Council expressed its intention to annex the territory described below, to the Village of Forest Lake, and

WHEREAS, no objections have been received from any party as to the proposed annexation,

THE VILLAGE COUNCIL OF THE VILLAGE OF FOREST LAKE, WASHINGTON COUNTY, MINNESOTA, ORDAINS:

Section 1. The corporate limits of the Village of Forest Lake are hereby extended to include the unplatted property described as follows:

That certain part of Government Lot One (1) in Section Sixteen (16), Township Thirty-two (32) North, Range Twenty-one (21), West of the Fourth Meridian, described as follows, to-wit:

Beginning at the Northwest corner of said Government Lot One (1); thence East along the north line thereof, for Six Hundred (600) feet to the point of beginning of the tract hereby described; thence South 31° East for One Hundred Twenty-nine (129) feet; thence North 74°12' East for Two Hundred Twenty-seven and 19/100 (227.19) feet to a point near the shore of Forest Lake; thence North 35°44' West along said lakeshore for Sixty (60) feet to the north line of said Government Lot One (1); thence West along said north line for Two Hundred Fifty (250) feet to the point of beginning. All riparian rights are included and specifically any strip of ground lying between described lakeshore course and the actual shoreline of the lake.

Section 2. The Village Clerk is directed to file certified copies of this Ordinance, together with the Affidavit of Publication thereof, with the Secretary of State, the County Auditor of Washington County, and the Minnesota Municipal Commission.

Section 3. This Ordinance takes effect upon its passage and publication and the filing of Certified copies as directed in Section 2. hereof.
